Our Mission Related Goal in our contract with Osprey Wilds is:

Measure 1.1 [CCR] - 10 Points: From FY19 to FY23, the aggregate percentage of students in grades 9-12 who will be on-track to graduate will be equal to or greater than 70%. This will be measured by calculating each student's credits at the end of each year, and noting whether or not they will be able to earn 22.5 credits by the end of senior year.

As of the end of Quarter 2, we have 83.3% (30/36) of students on track to graduate. I will report on Quarter 3 next month.

We expect three seniors to graduate this year.
